How to enroll in the course:

You can register online or at the driving school's customer service office.

It requires:

- valid identity documents, address card, tax ID (age 14 student ID card until full)
- declares that he/she has completed primary school education and that he/she has certificate, which must be presented in original to the authority during the theoretical exam, and the first copy of the document certifying medical fitness,
- and the student authorizes the educational institution to process his/her data during course and exam administration (further information is contained in the data processing information).
- Payment of the first tuition fee installment

A road vehicle driver who drives or intends to drive a road vehicle or a road vehicle with a distinctive sign within the framework of a road transport service, as well as one who is employed as a road vehicle driver, shall be classified in the 2nd aptitude group.

Our driving school provides basic traffic law (traffic rules) education within the framework of e-learning education. The e-learning curriculum is available for 75-90 hours within 180-365 days (depending on the selected package). After registering (simultaneously with enrollment), the student automatically receives the e-learning curriculum, which he must open within 30 days, if he fails to do so, he must enroll again. The opening is also the starting date of the course.

If the student does not complete the course material within the specified time interval, does not reach 100% progress and/or the course certificate cannot be downloaded, he/she can request an extension of the course material. The fee for this is 10,000 HUF, and access to the course material is extended by another 30 days and 10 hours, but the starting date of the course does NOT change. We can only extend the course material that does not fall outside the specified deadlines, see: Rights and obligations of the examinee

Conditions for applying for the course and taking the exam:

Category "B"

Conditions for applying for the course:

- Anyone who has reached the age of 17 or is no more than six months younger can be admitted to the course; (Consent of a legal representative is required until the age of 18!)
- payment of the first tuition fee installment;
- adult training contract concluded with the driving school
- a valid personal identification document and address card, tax ID card presented, or if you already have an existing driving license, it is required to be presented.

Conditions for taking the exam:

- a theoretical exam can be taken by anyone who meets the other conditions and has reached the age of 17 or is no more than three months younger;
- has completed the theoretical course and has less than, since the beginning of the course, more than 9 months have passed;
- completed and signed application form, valid medical fitness certificate;
- the applicant can read and write and has completed 8 grades of primary school declares
- payment of exam fee
- You can only take the practical exam after reaching the age of 17.
- practical exam only after completing the mandatory number of hours (29) and
You can do this after completing the required driving distance (580 km) if you have paid your driving test fee.

Driving practice can be started after the successful theoretical exam, in possession of a valid driving license, which will be held and maintained by the instructor.

Practical lessons are 50 minutes long.

Practical training:

In primary education, the student may lead 2 lessons per day. In secondary education, 2 hours. He may lead another 2 hours on the same day, with a minimum of 1 hour of rest time (24/2005. (IV.21.)

GKM. Regulation No. 3. Annex 3. 3.6. e) point). Practical training can only be started after passing the theoretical exam(s) and in possession of a certified driving license.

How to make up for an absence:

Missing practical classes can be made up in consultation with the instructor. Making up for an absence must be agreed in advance with the school principal.

How to pay tuition fees:

Category "B"

- **Theory:** 25-50,000 HUF (depending on the chosen e-learning curriculum package), which is also the first installment of the tuition fee (to be paid upon enrollment, which includes the e-learning curriculum fee and the enrollment fee)
- **Practice:** 11,500 HUF/hour (29 hours + 1 exam hour) 30 hours total: 345,000 HUF
- Additional hours: 11,500 HUF/hour

For transferred students, practical lessons start at 11,500 HUF/lesson.

The prices for the base and the additional hour are the same!

- FOR INTENSIVE TRAINING 11,500 HUF/hour

If the student has not completed the mandatory minimum of 29 hours and 580 km, he/she is NOT entitled to take the driving test!

In this case, it is mandatory to take a make-up lesson! If the previously announced driving test is missed for this reason, the instructor is obliged to refuse to participate in the test. This also applies to payment arrears. In the absence of payment, the student will be charged the fee for the missed driving test and the instructor's lesson fee for the driving test lesson. If the student does not pay, the school will not issue the training certificate or will take the case to civil litigation.

The following legislation is mandatory information, but in the case of Happy Car Driving School, both the training organization and the instructor are Debreczeni Tibor ev.

(Section 9 (1) The provisions of Decree 24/2005. (IV. 21.) of the Minister of Transport and Communications on the detailed rules for the training and examination of road vehicle drivers and road transport professionals [hereinafter: Decree 24/2005. (IV. 21.) of the Minister of Transport and Communications] in force on 18 December 2022 shall apply with the derogations set out in paragraphs (2) and (3).

(2) Section 3 of Decree 24/2005 (IV. 21.) of the Ministry of Interior shall apply with the following exceptions:

a) the establishment of a contractual relationship with the student for training, the conclusion of the contract, and the related general rules for the training and examination of road vehicle drivers and road transport professionals 179/2011. (IX. 2.)

Training costs pursuant to Section 2(1)(8) of Government Decree (hereinafter referred to as: training costs) cost), as well as the fees that form the basis thereof, and the right to collect and issue invoices is exclusively reserved to the training institution, which is obliged to inform the student thereof;

b) the training body informs the student in writing about the conditions of the training it provides and the admission to the examination, which includes the training cost and the fact that the professional trainer involved in the training is not entitled to receive any fees or compensation from the student; the training cost paid to the training body against invoice includes all fees related to the training;

c) the training body may involve a specialist trainer in its training activities in accordance with the provisions of Section 11 (3) of Act LXXVII of 2013 on Adult Training; the specialist trainer is entitled to remuneration for his/her training contribution exclusively from the training body providing the training.

The rights and obligations of the examinee:

Upon enrollment, the student must provide credible proof of completion of 8 elementary school grades.

The student is required to attend the theoretical course, and any absence from a class must be made up if it exceeds 10% of the required number of classes. The absence must be made up at a location and time agreed upon with the customer service office, in a class(es) that is the same as the topic of the missed class(es).

You are required to pay the tuition fee or the installment payment contract you have concluded.

The student must take **the theoretical exam** within 9 months of the start date of the course.

If the student does not appear at the exam event, it will not count as an exam.

In case of a failed exam, the 9 months are extended by an additional 3 months. Thus, in this case, the student must successfully pass the exam within 1 year from the date of the course.

Valid identification documents and a certificate proving completion of the 8th grade must be presented at the exam. If this is not done, the student will NOT be allowed to take the exam . If this is not done, the student will have to enroll in a new course.

The student must pass all exams within 2 years of passing the theoretical exam. A successful basic traffic knowledge (KRESZ) exam is valid for two years.

In case of a failed theoretical exam, the exam must be repeated in the given subject. If the candidate fails any of the exams within the given time, all other exams will be invalidated.

Only the Driving School can book an appointment for the first theoretical exam, after which the student can register at the regionally competent exam center and apply for another exam.

The re-examination fee must also be paid there, or at the customer reception during customer reception hours.

Only the Driving School can book an appointment for a practical exam.

In the event of a fifth failed driving test, the student must take a PÁV test.

The earliest date for requesting a retake exam: the day following the failed exam. (Depending on the workload of the exam center and considering the administrative procedural deadlines, the deadline for completing the exam request is a maximum of 60 days)

The student may change instructors or vehicles during the training in consultation with the school principal.

The time of the practical driving lesson is established by mutual agreement between the instructor and the student. The student must be in a state capable of driving. He/she must not be under the influence of alcohol, drugs or medications that adversely affect driving ability. (If the instructor nevertheless experiences this, the lesson will not be held! In this case, the student must pay for the previously agreed lessons.

Cancellations or changes can only be made to the instructor no later than 48 hours before the start of the lesson. If the student fails to meet the 48-hour obligation, the school will consider the lessons as missed.

The student is required to attend practical training at the pre-arranged time.

In case of absence, the student will lose the lesson fee paid at that time. The missed lessons must be documented in the "Additional instructional lessons" section of the driving record and the tuition fee must be paid again at the school.

At the pre-arranged place and time, both the instructor and the student are required to wait 20 minutes due to possible unforeseen delays.

If the doctor prescribes a restriction during the examination (e.g. hearing aid, glasses or contact lenses), the student is obliged to inform the school and the instructor and to act in accordance with the restriction when driving. If the exam cannot be held due to lack of glasses or contact lenses, the student is financially responsible.

The practical tuition fees are valid at the time of signing the contract and may change if the costs used as the basis for the calculation change (e.g.: Official regulations, fuel price changes, inflation, etc.). The driving school reserves the right to change prices!

The school provides the educational vehicle for the student.

If you already have a valid driving license or exam certificate, you must present it to the exam invigilator during the exams.

The exam fees must be paid before the actual exams. The time of the practical exams – for the purpose of paying the fees – is considered a class! The first theoretical exam can only be administered by the training body! The practical exam is administered by the instructor!

Category “B” exam fees:

Exam fees must be paid before the actual exams, at the exam center, 1119 Budapest Petzvál József utca 39, cashier's office or during customer reception hours at the customer reception desk, at the registration point and at the driving locations.

Information regarding the issuance of a driving license:

The Traffic Aptitude and Examination Center issues an exam certificate for a successful traffic test, which is forwarded electronically to the competent traffic administrative authority after the successful exam. The student, in possession of other certificates required for the qualification he/she wishes to obtain (e.g. certificate of first aid knowledge, medical fitness certificate, identity document, address card), may personally initiate the issuance of a driving license at the competent traffic administrative authority (document office or government window) from the day of the exam or may choose the automatic procedure based on a prior declaration, when he/she receives the document certifying the driving right electronically within 24 hours after the successful exam.

An important change regarding automatic document issuance will come into effect from July 1, 2025. According to the legislative amendment, the procedures concerned will become subject to a fee from that date. Section 34/A. (3) of Act LXXXIV of 1999 shall be repealed as of 01. 07. 2025, and accordingly, starting from 01. 07. 2025:

- the automatic document issuance procedure will become subject to a fee.
- the amount of fees (document issuance fee and postal service fee) is the same as the fees applicable in the application processing branch, in the personal procedure. The document issuance procedure for obtaining the first "B" category by a client under 25 years of age is also free of charge in the automatic branch.
- in cases initiated within the framework of automatic document issuance, the fee can only be paid electronically can be made via the payment interface provided for this purpose.

How can I pay the document issuance fee in the case of automatic document issuance?

- can only be done through the SZÜF interface, on the following service
via: www.magyarorszag.hu -> DOCUMENTS -> EXECUTIVES > PERMIT -
CAREER AND PAYMENT SERVICE.

Of course, this does not apply to those who have not yet proven their primary education. If you already have a driving license, bring it with you when you upgrade your category. For foreigners, the condition is a valid residence permit (at least 185 days) or a permanent registered address in Hungary (a person not subject to the personal data and address register must have a Hungarian residence permit valid for at least 185 days).

The existence of a permanent registered address in Hungary is also a condition for Hungarian citizens. (According to the relevant paragraph of Section 15 of Government Decree 326/2011 (XII.28.))

The first driving license is issued free of charge. A driving license validated for category "B" only entitles the driver to drive domestically until the driver reaches the age of 18. For two years from the date of first obtaining the driving license, the driving license is considered a beginner driving license.

Student transfer:

(1) The purpose of issuing and using the training certificate (certificate according to Annex 6) is to provide authentic information about the training completed by the student if the student wishes to continue his/her training at another training body.

(2) The dismissing training body records the fact of student transfer in the IT system of the examination center and issues a certificate with a unique identifier.

(3) The training body must issue the training certificate required for the transfer of the student within 3 working days upon the student's request; refusal to issue the certificate cannot prevent the student from transferring to another training body.

(4) If, despite the student's verifiable request, the training body does not issue the training certificate within the deadline, the examination center shall issue it at the student's request based on the theoretical course and practical hours recorded in the examination center's IT system.

(5) Based on the identifier of the training certificate issued by the dismissing training body or the examination centre through the examination centre's IT system, the receiving training body has access to the data of the student and the student's training.

Exam fee: 20,900 HUF (payable by check issued by the Hungarian Red Cross or online).

The exam fee paid to the Hungarian Red Cross account expires after the year following the subject year, after which you can only take the exam after paying the current exam fee again.

For the issuance of the examination certificate, the following must be submitted: -
are exempt from the obligation to obtain a certificate issued by the Hungarian Red Cross (hereinafter referred to as: Red Cross certificate) based on separate legislation:

- medical, dental, pharmaceutical, or other qualifications obtained at a medical university,
- a veterinary degree obtained at the University of Veterinary Science,
- midwives,
- dietician,
- ambulance officer,
- physiotherapist,
- health care professionals,
- graduate nurses

- those with a diploma (qualification), and
- Public health inspectors are college graduates, and
- graduates of a health vocational school (vocational school),
- also any candidate who
- a category “D” driving license between July 1 and December 31, 1983, or obtained a driver's license for the "trolleybus" category;
- after January 1:
 - a driving license for any vehicle category,
 - a driver's license for the "trolleybus" category,
 - In the categories of “Agricultural tractor”, “Motorcycle”, “Slow vehicle” obtained a road vehicle driver's license.

No further exemption from obtaining a Red Cross certificate can be granted.

Business conditions for **AM category** training

Applicants who have reached the age prescribed by separate legislation or are no more than half a year younger than that can enroll in our courses.

You can apply at the Happy Car Driving School's e-mail address or at Debreczeni Tibor, where, after verbal information, the student will receive the training body's business conditions, training program, and written information. We conclude a written Training Contract with each student before admission to the driving course. A contract concluded with a minor student must also be signed by the legal representative.

THEORETICAL TRAINING WITH E-LEARNING:

A training management system running on the e-Educatio IT system.

It organizes the training. Learning takes place by topic.

It records and evaluates the student's training progress, answers to control questions, and results.

Based on the evaluation of the student's performance, it also implements possible navigation requests according to the training program.

A student can only start a given part of the curriculum if they have already completed the previous one.

The system checks the conditions and deadlines for completing the education.

- Anyone who has attached the following to the duly completed application form can be admitted to the theoretical exam: **exam fee**

You have mastered the theoretical curriculum with the number of hours indicated above, meaning you have successfully completed the theoretical course and have reached the specified age.

No exemption from attending or taking the driving course-related subjects can be granted.

- According to regulations, the student must start his/her exams within 9 months from the start of the course (date of the first lecture), and must also pass the theoretical exam within 12 months from the same date. Beyond these deadlines, the student can only take the theoretical exam after repeating the course!

- The theoretical training ends with an official exam, which takes place at the following possible locations: 6200 **Kiskőrös**, Izsáki út 12. / 6000 **Kecskemét** Szent István krt. 19/a / 6300 **Kalocsa**, Miskei út 5. / 2400 **Dunaújváros**, Október 23. tér 10. / 2310 **Szigetszentmiklós**, Csepeli út 180/6. / 1119 **Budapest**, Petzvál J. u. 39.

Based on the permission received from the transport authority, instead of the written or computer-based theoretical exam:

a) a foreign citizen who does not speak or understand Hungarian at a native level (hereinafter referred to as: non-Hungarian speaker) may take an oral exam with the assistance of an interpreter, if no examination materials are available in the official language of the candidate's nationality,

b) a person who has difficulty understanding or reading text due to their health condition - as certified by an expert opinion issued by the Hungarian expert and rehabilitation committee examining learning ability - may also take the exam orally,

c) a hearing-impaired person - with a specialist certificate - who uses Hungarian Sign Language may, upon request, take an oral exam in Hungarian Sign Language with the assistance of a sign language interpreter registered in the National Register of Sign Language Interpreters.

For the examination with the assistance of an interpreter referred to in point a), the transport authority shall assign the interpreter from the National Translation and Translation Certification Office. If the National Translation and

If the Translation Certification Office cannot provide the interpretation, another suitable person who is proficient in the selected language must be assigned to provide it. The request for a theoretical exam with the assistance of an interpreter must be submitted to the transport authority at least 15 days before the requested exam date. The interpreter's remuneration is the responsibility of the examinee.

In the event of a failed theoretical exam, the candidate may retake the exam after paying the fee again and 3 working days after the failed exam. It is also possible to apply independently to the transport authority for a supplementary exam in the theoretical and safety inspection and operation subjects.

Practical training:

If your theoretical exam is successful, you can start practical preparation. Driving a vehicle begins with **basic training , vehicle handling / routine and technical / training** , in the so-called "closed track" format. During the Vehicle Handling and Routine Training, you will become familiar with the technical elements of the vehicle and how to handle them. After completing the mandatory number of lessons, you can start the Main Training. The driving location is Kiskyrös. During the practical training, **1 lesson is 50 minutes long** (2 lessons, can be combined) followed by a 10-minute break. During the **basic training** , you can attend **a maximum of 2 lessons** a day , and during the **main training** , **a maximum of 4 lessons** . The latter are divided into two - two hours, with a one-hour break in between. When scheduling practical driving, we adapt to your needs according to the possibilities. The table below records the mandatory **minimum practical hours and the number of kilometers** . If you feel you need to take extra lessons, you can request them. The fee for extra lessons is the current hourly rate.

When driving two-wheeled vehicles, the student is required to wear: protective gloves, protective long pants, protective jacket, high-heeled, closed shoes or boots and a helmet ! Depending on the design of the helmet, glasses must be worn. In the absence of appropriate clothing, the practical driving training and exam cannot be held.

For motorcyclists, they learn practical driving on a motorcycle of the type approved for their chosen category.

During the "AM" category practical driving training, the student may also practice with his/her own vehicle in proper technical condition, with a document proving compulsory liability insurance. In this case, the student is responsible for the safe transportation of the vehicle to the training location.

IMPORTANT: It is FORBIDDEN to drive two-wheeled vehicles without the supervision of a professional instructor!

Types of practical exams, conditions for taking the exam:

Anyone who is eligible to take the driving and routine test is:

- passed the theory test successfully
- has demonstrated participation in a mandatory number of hours of training
- suitable for road safety

Anyone who is eligible to take a driving test is:

- successfully passed a routine driving test

- **has demonstrated participation in a mandatory number of hours of training**
- **suitable for road safety**
- **fulfilled the prescribed driving distances**

In case of failure, the candidate may take another exam after paying the fee again (after the failed exam) after 3 working days. Only the training body (instructor, school principal) may register the candidate for a supplementary driving, routine and traffic exam.

If you have failed five times in the same category of driving tests within two years, you will have to take an extraordinary aptitude test. If you have obtained a "psychologically fit to drive" qualification there, you will no longer be required to take an extraordinary aptitude test in connection with a road driving test.

If the candidate does not pass the driving test within 2 years of the successful KRESZ exam, he/she can only take the theoretical and practical exam after re-enrollment.

The student has the right to:

Before starting the training, get informed and familiarize yourself with the training organization's business conditions and training its program

To cancel the training, request a refund under the specified conditions, and request an official certificate from the person who completed the course.

To make up for any absences from the theoretical course, you can attend the make-up class we offer or take another course.

Please coordinate the dates of practical driving with your instructor.

Cancel agreed driving lessons at least 3 working days in advance.

Request an invoice for your course fees.

Student responsibilities:

Attend all sessions (10% absence allowed during theory, per subject), the omissions must be made up for.

For practical driving, be at the exact location of the change, in a driving condition, and in appropriate clothing is required to appear.

Tuition must be paid as specified in the contract, with the option of interest-free installments for the duration of the course.

The training cost and the fees forming its basis are collected exclusively by the training organization. eligible.

In the case of Happy Car Driving School, Debreczeni Tibor is both the instructor and the training organization.

The professional trainer participating in the training is not entitled to receive any fees or compensation from the student based on Section 9, Section 2/a of Government Decree 577/2022 (XII.23.), the training cost paid to the training organization against invoice includes all fees related to the training. Training and examination may also take place within the framework of an intermediary service.

Student transfer:

- 1) The purpose of issuing and using the training certificate (certificate according to Annex 6) is to provide authentic information about the training completed by the student if the student wishes to continue their training at another training body.
- 2) The dismissing training body records the fact of student transfer in the IT system of the examination center and issues a certificate with a unique identifier.
- 3) The training body must issue the training certificate required for the transfer of the student within 3 working days upon the student's request; refusal to issue the certificate cannot prevent the student from transferring to another training body.
- 4) If, despite the student's verifiable request, the training body does not issue the training certificate within the deadline, the examination center shall issue it at the student's request based on the theoretical course and practical hours recorded in the examination center's IT system. (

Information regarding the issuance of a driving license:

The Examination Center issues an exam certificate for successful completion of the exam, which is then forwarded electronically to the competent Transport Administration Authority. After this, you can have your driving license made in person at any government window in Hungary.

To apply for a driving license, the following documents are required: a _____

certificate proving that you have acquired road first aid knowledge, a document serving as the basis for exemptions, a document proving your identity, and a residence card.
